With a fun program dedicated to a different story each year, Notte di Fiaba is the primary and traditional summer event in Riva del Garda. Music, dance, games, actors, and jugglers animate the streets and alleys of the city in the magical setting created by cheerful sets and Lake Garda. Even though it is an event dedicated to children, Notte di Fiaba has always fascinated adults. Eighty thousand

visitors and more than one hundred and sixty hours of entertainment are just some of the numbers of one of the most important events in Garda Trentino, passed down from generation to generation since 1950 and belonging to the entire community and its guests.

This year, Notte di Fiaba offers us a revisited version of "The Town Musicians of Bremen."

CONTEST REGULATIONS

Art. 1 Cultural Initiative

The 11th Notte di Fiaba International Illustration Competition is a cultural initiative promoted by Associazione Manifestazioni Rivane. Designed and organized in collaboration with leading representatives of the world of children's literature, publishing, and illustration, the competition will give life to a traveling illustration exhibition, its catalog, and the book illustrated by the competition winner and published by Giunti Editore.

The Jury will choose the four best illustrators, assign special mentions, and select a further group of illustrators whose works will be exhibited at the exhibition above and included in the relative catalog. The jury is looking for the winner among those who propose an "experimental" and "original" type of illustration that is not contaminated by stereotypes and styles from cartoons, comics, or manga.

The winners, those mentioned, and the participants in the exhibition will be revealed during the **Bologna Children's Book Fair 2025**. The illustrated book, the exhibition, and the exhibition catalog will be officially presented on the occasion of the inauguration of the exhibition at the **end of August 2025** in Riva del Garda.

Art. 2 How to participate

The competition is open to published and unpublished illustrators of any nationality, place of origin, or residence, with no age limit. For minors, express written authorization is required from one of the parents or whoever has parental authority. By midnight on March 8, 2025, competitors must send the following FILES via WETRANSFER to concorsonottedifiaba@gmail.com, indicating in the subject of the message "SURNAME_NAME_materiale concorso BREMA" (for example ROSSI_MARIO_materiale concorso BREMA).

A. The **STORYBOARD** created based on the text available in the final part of this contest regulation — the ILLUSTRATED PROJECT of the entire book, including cover and back cover — can be realized in graphite or color, must leave room enough for the text, but without showing the text itself.

The storyboard should be as clear and complete as possible. The illustrated book will be printed in 21x30 cm format and composed

of a cover, back cover, endpapers, and 32 internal pages as per the structure proposed below in the announcement.

The storyboard file must be a PDF with a maximum of 300 dpi and a maximum of 20 MB named "SURNAME_NAME_STORYBOARD" (for example, ROSSI MARIO STORYBOARD).

- **B. 2 DEFINITIVE ILLUSTRATIONS** made with a technique of your choice and taken from the storyboard above. The illustrations must be sent in the following formats:
 - 1. For possible inclusion in the catalog, it is necessary to save and send, as a TIFF at 300 DPI in CMYK (QUADRICROMY), one illustration sized 43x31 cm (1 double-page) and one illustration 21,5x31 cm (1 single-page, e.g., the frontispiece, or the last page), plus the bleeding of 0.5 cm for possible publication and framing for the exhibition. The files must be named indicating "SURNAME_NAME_TITLE_TIFF" (for example, ROSSI_MARIO_GALLO_TIFF and ROSSI_MARIO_FRONTESPIZIO_TIFF).
 - 2. For the evaluation of the Jury and online communication, the two illustrations above must also be saved and sent in JPEG format at 300 dpi in RGB of a maximum of 2MB with the COPYRIGHT symbol (©) indicated on the image border followed by the name and surname of the illustrator (for example @MarioRossi). The files must be named by indicating "SURNAME_NAME_TITLE_JPEG" (for example, ROSSI_MARIO_GALLO_JPEG and ROSSI_MARIO_FRONTESPIZIO_JPEG).
- C. Please create a brief CV with a conversational tone, using up to 250 words, written in the first person. Include your favorite inspiring artist and a quote about art. Additionally, provide your contact details such as email address, website, blog, Facebook page, Instagram, and online portfolio for inclusion in the catalog. The file should be submitted in text format (.DOC, .DOCX, .ODT, .PAGES, .PDF) with a maximum size of 1MB. It must be named as "SURNAME_NAME_CURRICULUM," for example, ROSSI_MARIO_CURRICULUM.
- **D.** A **PHOTO** of the illustrator in black and white,



5x5 cm in TIFF format at 300 dpi. The file must be named "SURNAME_NAME_PHOTO" (for example, ROSSI_MARIO_PHOTO).

E. The completed and signed REGISTRATION FORM in PDF format, not exceeding 1MB. The file should be named "SURNAME_NAME_REGISTRATION_MODULE" (e.g. ROSSI_MARIO_REGISTRATION_MODULE).

If the entry arrives after midnight on March 8, 2025, or is incomplete or does not correspond to the required formats, the competitor will be automatically excluded from the competition.

The outcome of the selection made by the jury for the competition and the exhibition will be communicated during the Children's Book Fair 2025 and subsequently on the social media accounts of "Notte di Fiaba" and "Notte di Fiaba Illustration Contest."

The illustrator who wins the competition will be immediately contacted by the publisher to work on the creation of the illustrated book and will have to deliver the final illustrations in a digital format by the date requested by the publisher.

Art. 3 The Competition theme

This year's competition theme is "The Town Musicians of Bremen."

Art. 4 Delivery and return of selected works

Please make sure to send the original illustrations selected for the exhibition no later than **May 31, 2025**. You will receive instructions on how to send the works from Notte di Fiaba via email or on its social media accounts. The illustrators must

- SIGN the back of their works
- Write in CAPITAL LETTERS their 1) name and surname, 2) title of the illustration and 3) technique used.

If the illustrations are created digitally, the selected illustrator must still send high-definition prints in the required formats. Failure to do so will lead to disqualification.

The selected artworks will be insured and displayed at the exhibition. They will also be featured in the exhibition catalog, other promotional materials related to the cultural initiative, and on the web marketing tools of Notte di Fiaba.

All works will be returned to their original creators at the end of the exhibition period, and this process must be completed by December 31, 2026.

Associazione Manifestazioni Rivane will return the original artworks via courier at the illustrator's expense. Alternatively, the illustrator may choose to personally collect their works from the headquarters of Associazione Manifestazioni Rivane at their own expense, by appointment, or designate a person with a suitable proxy to collect on their behalf.

Artworks spontaneously donated to Associazione Manifestazioni Rivane for the "Permanent Collection Notte di Fiaba" will not be returned. Instead, they will be used to promote children's illustrations during future events dedicated to children in Riva del Garda. Associazione Manifestazioni Rivane will not be held responsible for any loss and/or damage to the artworks during shipping or due to other problems related to the delivery or return process.

Art. 5 The Jury

The illustrations will be judged by a highly qualified jury of experts in art, illustration, literature, and children's publishing.

- Francesca Tancini President of the Jury (Art historian and PhD specialized in illustrated books, she is the coordinator of the European research project PiCoBoo on the role of color in illustrated books for children and has worked and curated exhibitions on illustration for children at Harvard, Yale, Princeton and Oxford)

- Matteo Gubellini (Award-winning illustrator and author)
- Eleonora Cumer (Award-winning illustrator and textile artist)

Art. 6 Prizes

The first place winner will receive a cash prize of €2,000 and will create the illustrations for the album, which will be published by Giunti Editore and officially presented at the illustration exhibition's inauguration. For the rights to reproduce and publish the illustrations, the winning illustrator will be paid 2% of the retail price, net of VAT, for each copy sold. The €2,000 awarded by Associazione Manifestazioni Rivane as the first prize for the Notte di Fiaba Competition will serve as a guaranteed advance and



- will be drawn from the aforementioned percentage and potentially additional compensation from other uses.
- The second place winner will receive a prize of €500.
- The third place winner will have the opportunity to attend Maestro Svjetlan Junakovic's advanced illustration course in Riva del Garda for free. If the course is canceled, the illustrator will receive a cash prize equivalent to the course cost: €300.
- 4. Additionally, a special "Livio Sossi for emerging talents" prize will be awarded. The winner will have the chance to attend Maestro Svjetlan Junakovic's advanced illustration course in Riva del Garda for free. If the course is canceled, the illustrator will receive a cash prize equivalent to the course cost: €300.

Art. 7 Responsibilities and rights

Attention all illustrators participating in the competition; by submitting your work, you grant us the non-exclusive right to reproduce and publish your art. Your work may be used in various digital media, such as websites, social networks, TV broadcasts, online and offline newspapers, etc.

It may also be used in promotional materials related to the cultural initiative (such as leaflets, flyers, invitations, posters, etc.), as well as in products for sale at the MAG bookshop and other retail locations during the event. Please note that this list is not exhaustive, and your work may be used in other ways as well. You will not receive any compensation for the use of your work.

All submitted and selected works must be original and autographed. By participating in the competition, you confirm that your work is original, and you agree to indemnify the organizing body against any claims. You also declare that your work complies with all relevant laws.

Your artwork may be created using any technique, as long as it meets the required format as per Art. 2. By entering the competition, you agree to all the conditions and clauses outlined in this regulation.
